The Executive Headteacher and Trustees of the School support the staff in the setting of homework as appropriate to the curriculum and the ability of the students.

Homework is a valuable part of a student's education and, thus, should be a means of supporting work done within the formal curriculum in school.

### Aims

In supporting the setting of homework, the school aims:

- to encourage students to develop the practice of independent learning;
- to allow the practice of skills learned in the classroom;
- to enable students to maximise classroom learning;
- to enable students to make use of materials and information sources not available to some classrooms;
- to involve parents (and other adults) in the student's work;
- to encourage students to see homework as an interesting, enjoyable activity and a positive help to their education.

In **Lower School**, each homework should last for twenty to thirty minutes.

In **Upper School**, each homework should last for forty-five minutes.

There will be times when the pattern of homework may be irregular in order to reflect the requirements of the courses, e.g. when coursework is being followed or during mock/real examination preparation.

Homework is set by each faculty according to the following guidelines:

**Homework:**

- Will be set according to the homework timetable published at the start of each academic year;
- should be set on a regular basis;
- should reflect the ability of the teaching group (or the individual student within the teaching group);
- should include activities which encourage learning by heart;
- should be an integral part of the work being taught.

**Might include:**

practice skills	tackling set questions	drafting
investigations	completing worksheets	extended pieces of work
research	creative and artistic activities	practical activities
revision		

As well as pre-learning of material which will be drawn upon in a future lesson.

**Expectations of Students**

Homework should encourage quality, not just an expectation of quantity.

- Students are expected to write down each homework in their Student Planner, including details of the subject, summary of work set (or no homework) date set and date to be completed.
- Students are expected to complete homework by the date set. Those who do not meet the deadlines should expect sanctions to be applied. These may include detentions, which could be after school.
- Students experiencing difficulties with homework should seek help from the appropriate teacher prior to the homework deadline.
- Students are expected to maintain a high level of presentation, handwriting and overall standard of work.

**Support from School**

Each homework will be acknowledged by the subject teacher. Some homework will be formally assessed. Students will be given prompt feedback about their work, including suggestions about how it might be improved.

The School Library is available as a study area each lunchtime and after school.
